Unit No: 2-54  
Unit Name: Aubrey Peak

1. Area Description: This unit is characterized by a series of rugged volcanic buttes and plugs, with colorful precipitous cliffs and intricate canyons. The vegetation consists primarily of a palo verde-saguaro community with Joshua trees.
2. Wilderness Characteristics:
  - A. Size: The unit consists of 20,040 acres of public land with an additional state inholding of 200 acres. The state land was not inventoried for wilderness suitability.
  - B. Naturalness: Approximately 4,800 acres in the north portion of the unit is recommended to be dropped from further consideration due to an intrusive jeep trail and to historical mining scars. The remainder of the unit remains in a natural condition unaffected by the works of man.
  - C. Outstanding Opportunities:
    1. Solitude: Size, topographic and botanical screening, and the complex character of the landscape combine to provide outstanding opportunities for solitude.
    2. Primitive and Unconfined Recreation: Unit 2-54 offers outstanding opportunities for hiking, backpacking, sightseeing for wildlife and geologic features, and photography.
  - D. Supplemental Values: Scenic, geologic and zoological sightseeing values enhance the wilderness quality of this unit.
3. Recommendation: Approximately 15,240 acres are recommended for further wilderness consideration.
4. Rationale for Recommendation: The area proposed offers outstanding opportunities for solitude and for primitive and unconfined recreation.

Unit No: 2-56  
Unit Name: Black Mesa

1. Area Description: The unit consists of a large volcanic mesa, approximately 6 miles long and 4 miles wide, which slopes gently toward the southwest. The east side has precipitous walls which rise over 900 feet above the hills below. The mesa top is dissected by numerous small canyons which drain to the south and west. The vegetation consists primarily of a palo verde-saguaro community.
2. Wilderness Characteristics:
  - A. Size: The unit consists of 21,700 acres of public land.
  - B. Naturalness: Due to several mining and road intrusions in the south portion of the unit, approximately 4,690 acres are recommended to be dropped from further consideration. The remainder of the unit is free of substantial intrusions and remains in a natural condition.
  - C. Outstanding Opportunities:
    1. Solitude: The unit size and intricate terrain provides outstanding opportunities for solitude.
    2. Primitive and Unconfined Recreation: The unit provides outstanding opportunities for primitive recreation including hiking, backpacking, photography, and birdwatching.
  - D. Supplemental Values: The unit offers outstanding opportunities for the student of ornithology as well as for birdwatchers.
3. Recommendation: Approximately 17,010 acres are recommended for further wilderness consideration.
4. Rationale for Recommendation: The area proposed offers outstanding opportunities for solitude and for primitive and unconfined recreation.

Unit No: 2-57  
Unit Name: Centennial Wash

1. Area Description: The unit consists of a small network of hills which rise gently above the surrounding lowlands. South of these hills the terrain consists of a low southwest draining outwash plain dissected by several small washes which drain into Centennial Wash.
2. Wilderness Characteristics:
  - A. Size: The unit contains 6,500 acres of public land.
  - B. Naturalness: Most of the west portion of the unit centered around Centennial Wash and its numerous tributaries remains in a natural state. The southeast portion of the unit is impacted by several exploration trails and prospects, and an area in the north and northeast portion of the unit is impacted by mining scars.
  - C. Outstanding Opportunities:
    1. Solitude: Although portions of the unit offer some opportunity for solitude, these are limited by the lack of vegetative and topographic screening and by the presence of the works of man.
    2. Primitive and Unconfined Recreation: The unit offers opportunities for botanical sightseeing and for birdwatching, but these cannot be considered outstanding when compared to others of its kind.
  - D. Supplemental Values: Since this unit does not meet all of the above criteria this narrative is not applicable.
3. Recommendation: This unit does not qualify for wilderness study.
4. Rationale for Recommendation: The unit lacks opportunities for solitude or for a primitive recreation.

Unit No: 2-58

Unit Name: Rawhide Mountains

1. **Area Description:** This unit is located in west-central Arizona immediately west of Lake Alamo State Park. The unit is in both Mohave and Yuma counties, and includes portions of the Rawhide and Buckskin Mountains. The topography is characterized by low hills, rugged peaks, and the 600 foot deep Bill Williams River canyon which meanders 8 miles through the unit. Biologically the unit is of Lower Sonoran life zone, consisting of palo verde-saguaro and creosote-bursage communities.
2. **Wilderness Characteristics:**
  - A. **Size:** The initial inventory unit contained approximately 71,900 acres, plus an additional 1,920 acres in private inholdings.
  - B. **Naturalness:** Man-made features, primarily in the form of mining operations and access roads render portions of the unit unnatural. Three mines in the north-central portion, one in the northwest, two in the southwest, and two mines in south-central portions of the unit impair wilderness suitability in those immediate areas. Jeep trails in the Butler Valley and a powerline and service trail in the southeast portion of the unit render that area unnatural. The above intrusions eliminate approximately 9,600 acres.
  - C. **Outstanding Opportunities:**
    1. **Solitude:** The unit's size, topography and vegetative screening provide an outstanding opportunity for solitude.
    2. **Primitive and Unconfined Recreation:** Many forms of primitive recreation present themselves in this unit. The varied terrain, presence of perennial water and outstanding scenery provide excellent opportunities for backpacking, hiking, sightseeing, photography, and bird-watching.
  - D. **Supplemental Values:** This unit's perennial river, the Bill Williams, has carved a scenic and intricate canyon, featuring a well developed riparian community.
3. **Recommendation:** Approximately 62,300 acres are proposed for further wilderness study.
4. **Rationale for Recommendation:** The area proposed remains in a natural condition, and provides an outstanding opportunity for primitive recreation and solitude.

Unit No: 2-59

Unit Name: Arrastra Mountain

1. **Area Description:** This unit is located in the southeast corner of Mohave County approximately 20 miles southeast of Wikieup and 8 miles northeast of Alamo Dam. Sections of the Big Sandy and Santa Maria Rivers are included in the unit. The Arrastra Mountain unit is a large diverse area (10 miles by 14 miles), featuring portions of the Poachie and Artillery Mountains. The unit is punctuated by rugged peaks, deep winding canyons, volcanic mesas and rolling hills. Vegetation is of both Lower and Upper Sonoran Life Zone. (Sonoran desertscrub with mohave desertscrub influence, and chaparral).
2. **Wilderness Characteristics:**
  - A. **Size:** The initial inventory unit consisted of 147,600 acres with an additional 640 acres in one state inholding.
  - B. **Naturalness:** The majority of this unit retains its pristine character. Four areas within the unit have lost their naturalness due to man's imprint. 1) Area immediately south and west of Artillery Peak bears scars of uranium exploration. 2) South of Santa Maria River, evidence of mineral exploration. 3) Range improvements and access roads in the northeast corner. 4) West end of Poachie Mountains are scarred by mining operations. These areas are excluded from the Wilderness Study Area.
  - C. **Outstanding Opportunities:**
    1. **Solitude:** Opportunities for solitude are outstanding due to the large size of the area, wide variety of landforms, and the diversity and density of vegetation.
    2. **Primitive and Unconfined Recreation:** Several types of outstanding recreational opportunities exist in this unit. Hiking, backpacking, birdwatching and zoological sightseeing are present. Perennial water is available throughout most of the unit.
  - D. **Supplemental Values:** Several supplemental values occur within the unit. The presence of perennial water, in the Big Sandy and Santa Maria Rivers provides additional recreational opportunities as well as opportunities for wildlife. The unit's plant and animal diversity provide an interesting "laboratory" for the scientist and naturalist. Raptors are particularly abundant in this unit.
3. **Recommendation:** Approximately 108,285 acres of this unit are recommended for further wilderness study.
4. **Rationale for Recommendation:** This unit's large, undisturbed area provide excellent opportunities for solitude and primitive recreation.

Unit No: 2-50  
Unit Name: Potts Mountain

1. Area Description: This unit is located in southern Mohave County approximately 12 miles northwest of Alamo Dam. The unit is dominated by Potts Mountain, a 3,378 foot volcanic plug, which rises symmetrically 1,200 feet above the surrounding terrain. The west portion of the unit is dominated by two parallel volcanic ridges. The vegetation consists of a palo verde-saguaro community with Joshua trees.
2. Wilderness Characteristics:
  - A. Size: The unit includes 5,400 acres of public land.
  - B. Naturalness: A north-south jeep trail through the center of the unit effectively divides this unit into two small areas. The eastern half, dominated by Potts Mountains, bears several trails and mine excavations. The west half is in a natural condition.
  - C. Outstanding Opportunities:
    1. Solitude: The unit's small size and number of intrusions severely limit the opportunities for solitude.
    2. Primitive and Unconfined Recreation: The unit does not offer outstanding opportunities for primitive and unconfined recreation.
  - D. Supplemental Values: Since the unit does not meet all of the above criteria this narrative is not applicable.
3. Recommendation: This unit does not qualify for wilderness study.
4. Rationale for Recommendation: The area is not of sufficient size to make practicable its preservation and use in an unimpaired condition, nor does it offer outstanding opportunities for solitude or a primitive and unconfined recreation.

Unit No: 2-51  
Unit Name: Dutch Flat

1. Area Description: This unit consists of a southern portion of Dutch Flat, a large plain located south and east of Yucca.
2. Wilderness Characteristics:
  - A. Size: The unit consists of 17,230 acres of public land.
  - B. Naturalness: The majority of the unit remains in a natural condition with the landscape unaffected by the works of man. In three small areas, the naturalness of the unit is disturbed by intrusions. These portions have been excluded from further consideration.
  - C. Outstanding Opportunities:
    1. Solitude: Although certain opportunities for solitude do exist within the unit, the lack of vegetative and topographic screening limit these opportunities.
    2. Primitive and Unconfined Recreation: The unit does not offer outstanding opportunities for primitive and unconfined recreation.
  - D. Supplemental Values: Since this unit does not meet all of the above criteria this narrative is not applicable.
3. Recommendation: This unit does not qualify for wilderness study.
4. Rationale for Recommendation: The unit does not offer outstanding opportunities for either solitude or primitive and unconfined recreation.

Unit No: 2-53  
Unit Name: Planet NE

1. Area Description: This unit consists of a volcanic flow intricately dissected by washes which have cut small narrow cauyous. Three large basalt plugs dominate the center of the unit while the south portion is dominated by a highly dissected "hill and wash" plain which drains southwest into the Bill Williams River. The vegetation consists primarily of a sparse palo verde-saguaro community.
2. Wilderness Characteristics:
  - A. Size: The unit consists of 12,765 acres of public land.
  - B. Naturalness: This unit has been primarily affected by the forces of nature and remains in a natural condition. The few intrusions within the unit are substantially unnoticeable and do not impair wilderness suitability.
  - C. Outstanding Opportunities:
    1. Solitude: The topographic complexity provides outstanding opportunities for solitude.
    2. Primitive and Unconfined Recreation: This unit provides outstanding opportunities for hiking, backpacking, and geological and zoological sightseeing.
  - D. Supplemental Values: This unit provides opportunities for geological and zoological sightseeing.
3. Recommendation: Approximately 12,765 acres are recommended for further wilderness study.
4. Rationale for Recommendation: This unit offers outstanding opportunities for solitude and primitive and unconfined recreation.

Unit No: 2-37/43  
Unit Name: Wabayuma Peak

- Area Description: This unit includes a section of the Hualapai Mountains in west-central Arizona. In less than five miles these rugged mountains rise precipitiously nearly 5,000 feet above the desert floor.
- Wilderness Characteristics:
  - Size: This unit was originally treated as two units of 15,000 and 24,300 acres. However, field inventory determined that portions of the way separating the two units did not meet the road criteria; therefore, the two units were connected. This new initial unit contains 39,300 acres of public land with an additional 1,760 acres in private inholdings. The private lands were not studied for wilderness suitability.
  - Naturalness: An area in the northeast part of the unit was found to contain numerous jeep trails. Although they do not meet the road criteria, the accumulative impact on the naturalness necessitates dropping this area from the unit. Two other small areas along the east boundary of the unit were also found to be intruded and were dropped from further consideration. The remaining impacts do not substantially impair naturalness.
  - Outstanding Opportunities:
    - Solitude: Size, dense vegetation, and rugged topography provide an outstanding opportunity for solitude.
    - Primitive and Unconfined Recreation: This unit provides opportunities for hiking, backpacking, and botanical and zoological sightseeing.
  - Supplemental Values: Due to the number of vegetative zones within the unit there is an outstanding opportunity for biological and ecological observation and study.
- Recommendation: Approximately 37,450 acres are recommended for further wilderness study.
- Rationale for Recommendation: The area proposed offers outstanding opportunities for solitude and primitive recreation, and is a natural condition.

Unit No: 2-46  
Unit Name: Natural Corrals Wash

- Area Description: This unit is on the east slope of the southern extension of the Hualapai Mountains in west-central Arizona directly west and adjacent to the town of Wikieup. The unit is characterized by a large plain and bajada, and by rolling hills which rise westwardly up to 4,728 feet. Vegetation consists of palo verde-saguaro and chaparral communities with some juniper.
- Wilderness Characteristics:
  - Size: 22,000 acres of public land with 680 acres in private in holdings. The private lands were not studied for wilderness suitability.
  - Naturalness: With the exception of a few small areas the unit was considered to be essentially natural.
  - Outstanding Opportunities:
    - Solitude: Due to the number of intrusions within the unit and to the close proximity to Wikieup, the unit does not offer outstanding opportunities for solitude.
    - Primitive and Unconfined Recreation: Opportunities for primitive recreation are limited due to the uniform terrain and number of intrusions.
  - Supplemental Values: Since this unit does not meet all of the above criteria this narrative is not applicable.
- Recommendation: This unit does not qualify for wilderness study.
- Rationale for Recommendation: This unit lacks outstanding opportunities for solitude and primitive recreation.

Unit No: 2-48  
Unit Name: Dugwell Canyon

- Area Description: This unit is located in west-central Arizona 9 miles west of Wikieup. It is on the east slope of the southern extension of the Hualapai Mountains. Vegetation consists of a Chaparral community with some pinyon and juniper.
- Wilderness Characteristics:
  - Size: 17,700 acres of public land.
  - Naturalness: While much of the land in this unit remains in a natural state, lengthy corridors leading into the heart of the unit attest to the historic as well as present human activity.
  - Outstanding Opportunities:
    - Solitude: The northwest and southwest portions of the unit offer good opportunities for solitude; however, these are limited by the area size. Throughout most of the unit the frequent occurrence of human impacts limit the potential for solitude.
    - Primitive and Unconfined Recreation: Opportunities for primitive recreation are limited due to the uniform terrain and frequent occurrence of intrusions.
  - Supplemental Values: Since this unit does not meet all of the above criteria this narrative is not applicable.
- Recommendation: This unit does not qualify for wilderness study.
- Rationale for Recommendation: This unit lacks opportunities for solitude and primitive recreation.

Unit No: 2-63  
Unit Name: Santa Maria River

1. Area Description: This unit is located in southwestern Yavapai County about 6 miles south of Bagdad. It consists of rolling hills, a portion of the Santa Maria River plain, and a fairly complex network of side canyons. Vegetation consists mostly of a palo verde-saguaro community with some mesquite. A cottonwood-willow community occurs in the major side canyon within the unit.
2. Wilderness Characteristics:
  - A. Size: This unit contains 14,462 acres of public land. An additional 880 acres of private inholdings also occur, but was not inventoried for wilderness suitability.
  - B. Naturalness: Many range improvements, prospecting scars, and road and trail access to these intrusions render the east half and the northern quarter of the unit unnatural. The remaining 5,410 acres surrounding the canyon area in the southwest corner are free of intrusions.
  - C. Outstanding Opportunities:
    1. Solitude: Although the opportunities for solitude are good in the natural canyon area and along the river, the restrictiveness of the travel corridors limits this opportunity.
    2. Primitive and Unconfined Recreation: Opportunities for hiking, nature photography, and birdwatching are good but are not considered to be outstanding.
  - D. Supplemental Values: Since this unit does not meet all of the above criteria, this narrative is not applicable.
3. Recommendation: This unit does not qualify for wilderness study.
4. Rationale for Recommendation: Most of this unit displays noticeable evidence of man's presence. The opportunities for solitude or primitive recreation are not outstanding among others of their kind.

Unit No: 2-65  
Unit Name: Greenwood Peak

1. Area Description: The unit contains the north end of the Poachie Mountains with Greenwood Peak being the dominant feature. Portions of the Burro Creek canyon is included within the unit. The vegetation consists primarily of a palo verde-saguaro community with chaparral at the higher elevations.
2. Wilderness Characteristics:
  - A. Size: The unit consists of 9,400 acres of public land with an additional 640 acres in private inholding. The private land was not inventoried for wilderness suitability.
  - B. Naturalness: An area of approximately 4,000 acres is recommended being dropped from further consideration due to the impacts created by several trails and range improvements. The remainder of the unit remains in a natural condition unaffected by the works of man.
  - C. Outstanding Opportunities:
    1. Solitude: Opportunity for solitude is limited by the small size and irregular shape of the unit.
    2. Primitive and Unconfined Recreation: Although some opportunity for primitive recreation occurs, this is limited by the size and shape of the unit.
  - D. Supplemental Values: Since this unit does not meet all of the above criteria this narrative is not applicable.
3. Recommendation: This area does not qualify for wilderness study.
4. Rationale for Recommendation: Due to the small size and irregular shape, the unit does not offer outstanding opportunities for either solitude or primitive recreation.

Unit No: 2-67  
Unit Name: Pine Creek

1. Area Description: The unit consists of a portion of the upper reaches of Burro Creek surrounded by a broad, gently rolling mesa. Pine Creek cuts into the mesa in the northeast corner. The vegetation consists primarily of a chaparral community with some juniper and pinyon.
2. Wilderness Characteristics:
  - A. Size: This unit consists of 9,900 acres of public land.
  - B. Naturalness: Due to the imprint of man, unit 2-67 does not contain 5,000 contiguous acres in a natural condition. Several ways and range improvements impact the naturalness.
  - C. Outstanding Opportunities:
    1. Solitude: Although some opportunities for solitude occur these are limited by the presence of intrusions and by the unit's small size.
    2. Primitive and Unconfined Recreation: Outstanding opportunities for hiking, backpacking, photography and birdwatching occur in portions of the unit.
  - D. Supplemental Values: Since this unit does not meet all of the above criteria this narrative is not applicable.
3. Recommendation: This unit does not qualify for wilderness study.
4. Rationale for Recommendation: Due to the small size and lack of naturalness this area does not qualify for wilderness study.

Unit No: 2-60  
Unit Name: Lower Burro Creek

- Area Description:** The Lower Burro Creek unit is located in Mohave County, approximately 10 miles southeast of Wikieup. The center of this unit is comprised of a intricately dissected butte featuring a maze of crags, spires, overhangs and ridges. Burro Creek traverses 8 miles of the unit, and meanders sharply in an open, but often steep-walled canyon. Vegetation is Lower Sonoran with Upper Sonoran represented in the southern portion of the unit. Both broadleaf and desert riparian communities occur.
- Wilderness Characteristics:**
  - Size:** The inventory unit consists of nearly 23,700 acres of BLM administered land.
  - Naturalness:** Only small portions of this unit have been affected by man's work. All intrusions except one occur on or near the unit boundary, the exception being a millsite in the southeast portion of the unit. The remainder of the unit is natural.
  - Outstanding Opportunities:**
    - Solitude:** The density of isolated canyons, the meandering of Burro Creek and its riparian vegetation provide dispersed focal points allowing for an outstanding opportunity to avoid the sites and sounds of man.
    - Primitive and Unconfined Recreation:** The rugged nature of the canyon country and perennial waters provide outstanding backpacking and hiking opportunities. The unit's accessibility enhances one's opportunity. This area is a favorite of rockhounds, providing geologic sightseeing as well as botanical and zoological.
  - Supplemental Values:** The colorful and rugged canyons and interesting vegetation combine to produce a unique scenic area. Six Arizona state-listed Threatened and Unique Wildlife Species occur within the unit.
- Recommendation:** Approximately 22,300 acres are recommended for further wilderness study.
- Rationale for Recommendation:** The proposed area remains in a natural condition, and provides an excellent opportunity for solitude and primitive recreation.

Unit No: 2-61  
Unit Name: Kaiser Springs Canyon

**Area Description:** Unit 2-61 is located in west-central Arizona, 9 miles east of Wikieup and 25 miles northwest of Bagdad. The unit is characterized by several small basalt mesas which rise 1,000 to 1,400 feet above the surrounding canyons. Vegetation is Upper Sonoran, consisting of open chaparral, arid grassland and chaparral-pinyon-juniper mix.

**Wilderness Characteristics:**

- Size:** The inventory unit consists of approximately 10,800 acres of contiguous public lands.
- Naturalness:** The imprint of man's work is substantially unnoticeable within the unit. Naturalness is somewhat affected by 6 windmills and their access ways in the southern portion of the unit, but are effectively screened by topography and vegetation.
- Outstanding Opportunities:**
  - Solitude:** The unit's small size and open terrain limit one's opportunity for solitude. Although solitude can be found it can not be said to be outstanding.
  - Primitive and Unconfined Recreation:** Good opportunities for primitive recreation exist but are not considered outstanding. The lack of variety or challenging terrain severely limited the recreational opportunities.
- Supplemental Values:** Since this unit does not meet all of the above criteria this narrative is not applicable.

**Recommendation:** This unit does not qualify for wilderness study.

**Rationale for Recommendation:** While this unit is essentially natural it does not provide outstanding opportunities for recreation or solitude.

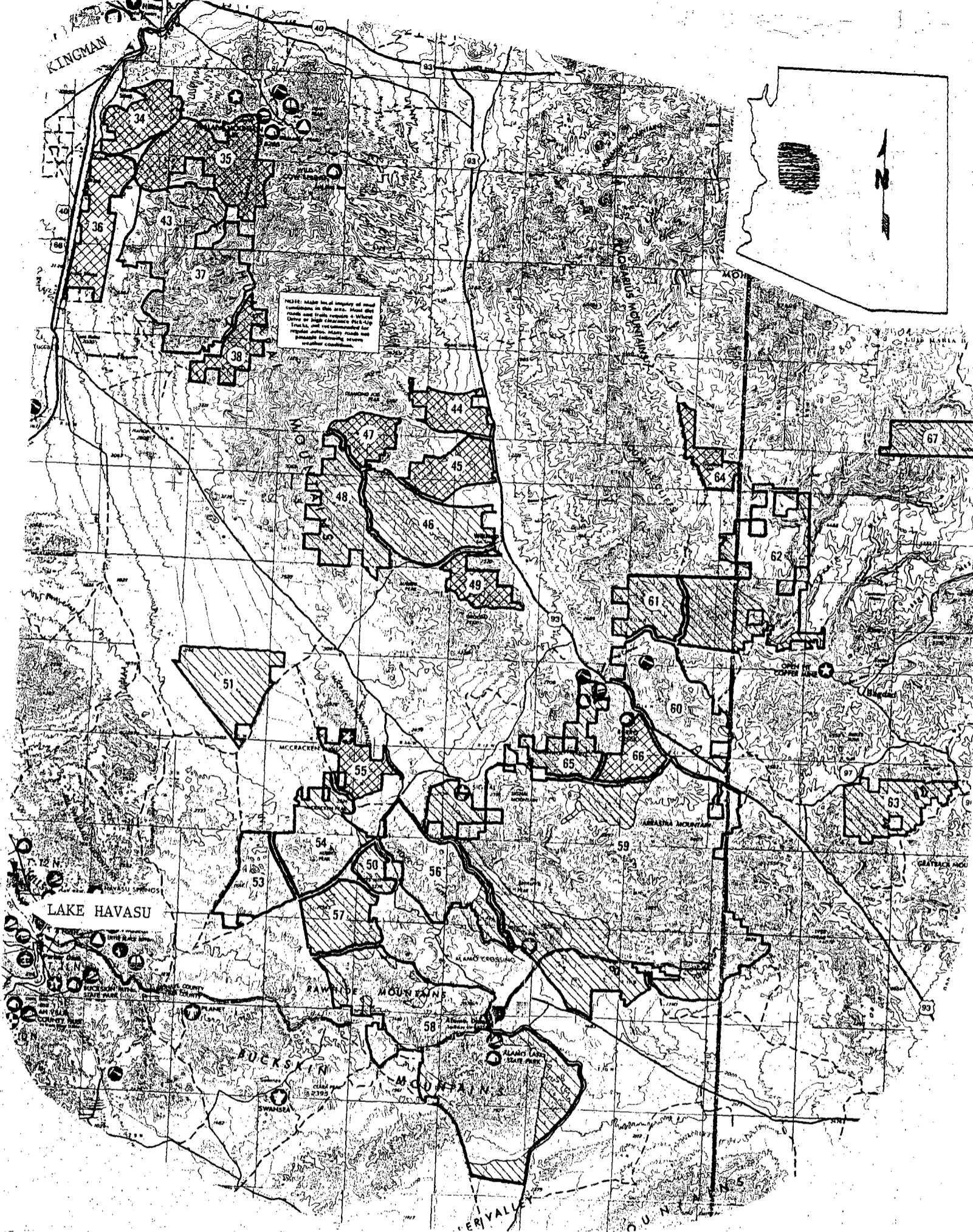

Unit No: 2-62  
Unit Name: Upper Burro Creek

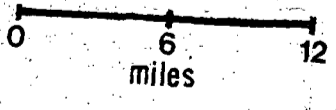
- Area Description:** This unit is located in west-central Arizona, 18 miles east of Wikieup and 4 miles northwest of Bagdad. The unit contains a variety of topographic features. The northern portion consists of a large, rolling mesa and a rugged tributary canyon of Frances Creek. Burro Creek runs the entire length of the unit and features a broad, but deeply incised canyon. Vegetation consists of an arid grassland, open chaparral, and chaparral-pinyon-juniper mix, and several riparian communities.
- Wilderness Characteristics:**
  - Size:** This unit contains approximately 33,300 acres of contiguous public land. An additional 1,900 acres are state owned, and 640 acres are in private inholdings. State and private lands were not inventoried for wilderness suitability.
  - Naturalness:** The majority of the unit remains in an unimpaired condition. An eastern portion of the unit along Burro Creek is unnatural due to the presence of two pumphouses and their access road. Range improvements along the Bagdad pipeline road and Bogle Ranch road render those portions unnatural.
  - Outstanding Opportunities:**
    - Solitude:** Although an excellent opportunity for solitude does exist within the unit, several factors combine to limit its outstandingness. The relative flatness of Goodwin Mesa and the travel corridor of Burro Creek limit one's ability to be isolated from man.
    - Primitive and Unconfined Recreation:** This unit provides an outstanding opportunity for several forms of recreation. Included are backpacking, hiking, photography, botanical and zoological sightseeing. The variation in terrain and vegetation enhances these opportunities, as does the presence of perennial water in Burro Creek.
  - Supplemental Values:** The presence of perennial water in Burro Creek drainage provides for a variety of plant and animal life. 267 species of vertebrates including 6 state-listed Threatened and Unique species can be found in this unit. The unit also has evidence of considerable prehistoric habitation.
- Recommendation:** Approximately 28,190 acres of this unit are recommended for further wilderness consideration.
- Rationale for Recommendation:** This unit features outstanding supplemental values as well as an outstanding opportunity for primitive recreation. The area is also in a natural state, undisturbed by man's activities.
