

Resource and Land Investigations (RALI) Program

The Resource and Land Investigations (RALI) Program was established by Secretarial Order in 1972 to provide an Interior Department mechanism that would improve technical communications between the collectors and analysts of resource and land information and the users of such information. State and Regional planners, as well as other land and resource analysts frequently are unable to obtain and use natural science information effectively in support of land use and resource management decisionmaking. This results, basically, from two problems: (1) lack of adequate information and (2) inability to fully utilize available information. The U.S. Department of the Interior has a vital interest in and responsibility for both assuring and encouraging the proper utilization of the Nation's land and natural resources, which is manifest as a need to address the problem of facilitating the use of resource information by planners. While Interior Department Bureaus and Offices have missions directly supportive of these responsibilities, their activities tend to focus on specific segments of the overall problem. A primary objective of the RALI Program is to facilitate multi-Bureau communication and coordination in those instances where a multidisciplinary perspective and multi-Bureau interaction will improve the Department's ability to service the users of land and resource information in general and the planning community at State and Regional levels in particular. In order to carry out its mission, the RALI Program pursues projects which have the following set of purposes:

- Information dissemination, including the compilation of directories, catalogs, and bibliographies;

- Methodology development, whereby the information base can be used to generate, analyze, and evaluate alternatives in land and resource planning;

- Product evaluation, in which the utility of methodologies and the usefulness of information products are tested against real world problems of the planning community;

- Technology transfer, including the packaging of information in usable forms, the conduct of workshops and other educational procedures, and the provision of technical assistance to the State and Regional Planning community.
