This letter is submitted as an addendum to the above referenced report and may be cited as authority for the additions and changes listed below.


AMAX hereby requests permission to add location 21-16 NENWNW Sec 16 T23N R40E (Exhibit "A") to the existing Plan of Exploration (November 1980) for the McCoy Unit. The location is on one of the mine roads at the McCoy Mine and is in the disturbed area from the previous mining activity. Therefore, we have not planned an archeological examination.

The attachments include (1) Exhibit "A" showing the requested location in relation to well 38-9 which was drilled in 1981, (2) a GDP for well 21-16 to be drilled to depths of 2,000-4,000 feet under Drilling Program I or II of the above POE, and (3) a plat showing location of the proposed hole.

The start up date for this well could be as early as January 7, 1983.

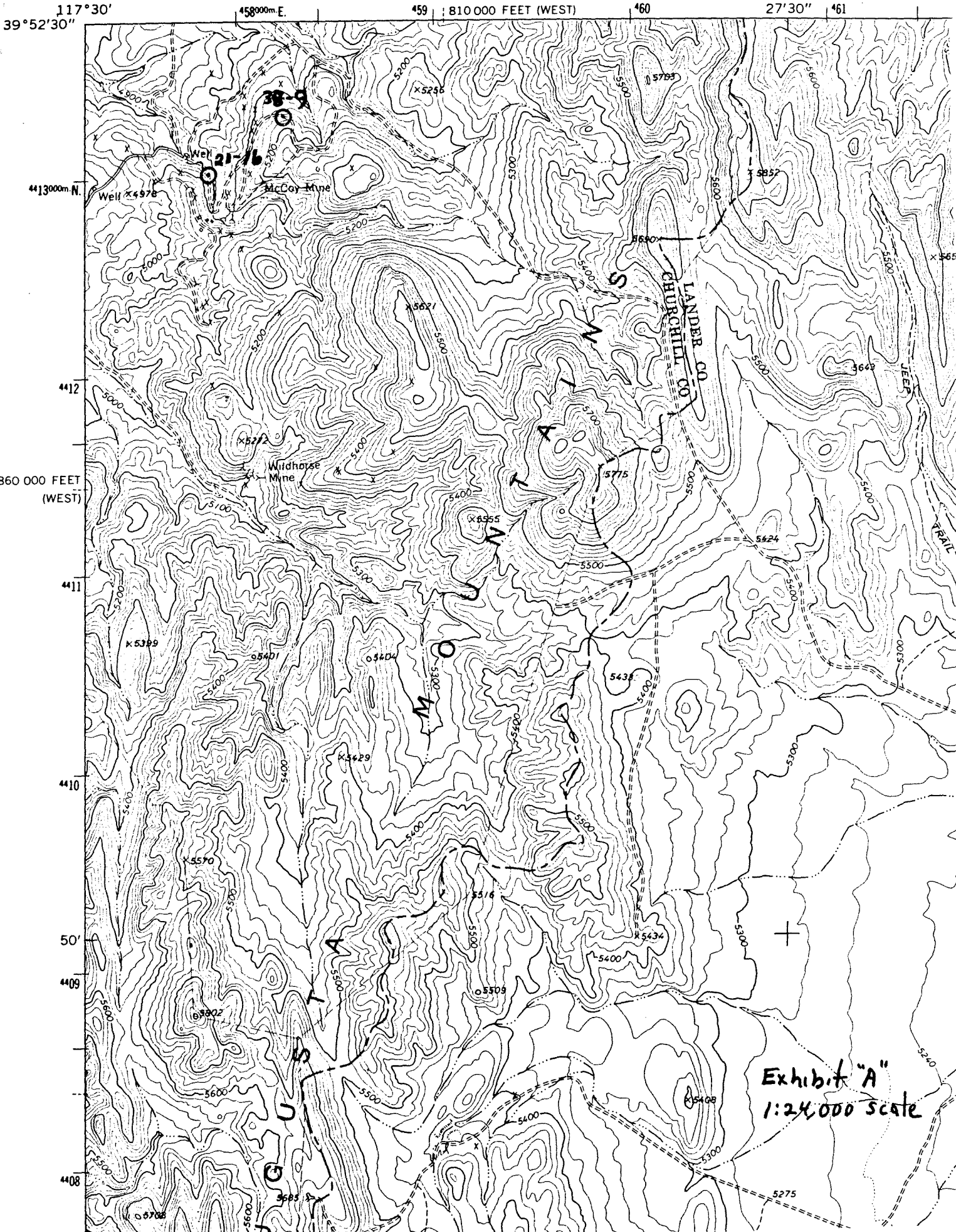
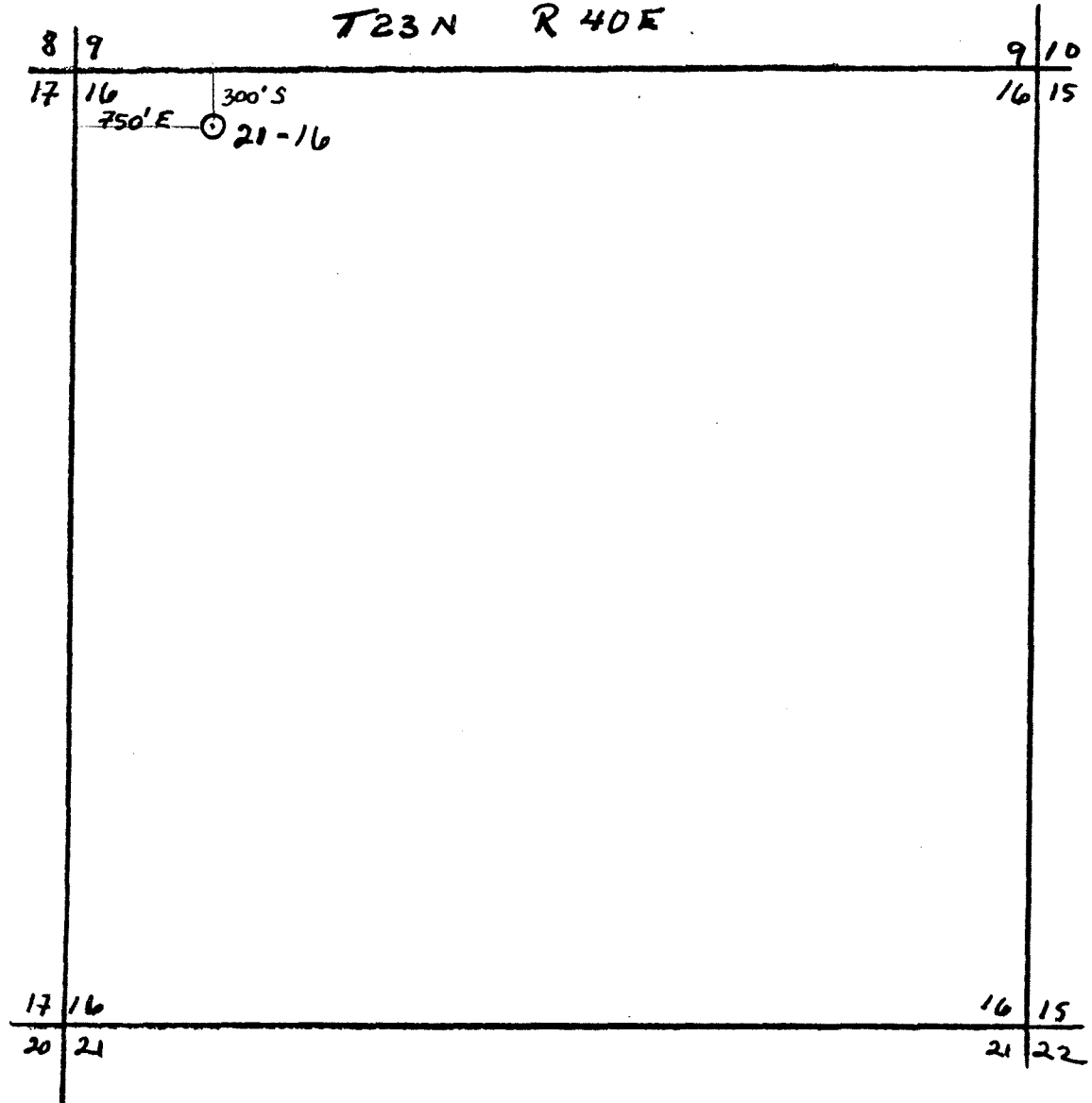


