1. On September 26, 1977 we received approval from the State of Utah to drill the following 610 m holes:

The expiration date on the permit for the above 6 holes is March 26, 1978. Please have this permit extended for one full year to March 26, 1979, if possible.

2. Also would you check to determine if the following hole was added to the State Permit as I requested after we were told by Fillmore BLM that they did not have jurisdiction over the lands with severed mineral rights:

If the hole 777-17 has not been added to the permit, please obtain permit for the same from State of Utah with a one-year completion time.

3. We have an approved Notice of Intent U-050-GO-49 from the Warm Springs BLM Resource Area, Fillmore, Utah. The permit expires on October 1, 1978 and because of the possibility of nesting raptors, drilling should be done between May 1 and October 1. The hole location is:

4. We have also received an approved permit from the U. S. Geological Survey for one 610 meter thermal gradient hole on Lease U-34427 in Millard County. The permit was approved December 12, 1977 and is good for one year. The permit number is AGS-69-U34427:


